Mac Richardson, Reg. Land Surveyor, in April 1947. Described as a whole, the said land is bounded by lands now or formerly on the northwest by C. W. Owens; on the northeast by lands of J. D. Chastain; on the southeast by lands of Brady; and on the southwest by the Saluda River and the said Brady.
