All that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 300-A of a revision of a subdivision known as Botany Woods, Sector VI according to a plat thereof prepared May 15, 1963 by Piedmont Engineering Service and recorded in the R.M.C. Office for Greenville County in Plat Book YY at Page 131, and being described as follows:

BEGINNING at an iron pin on the northern side of Botany Road at the joint corner of Lots 303 and 300-A and running thence along the joint line of said lots, N. 32-30 W. 140 feet to an iron pin at the joint corner of Lots 303 and 301; running thence along the joint line of Lots 300-A and 301, N. 8-07 W. 145.6 feet to an iron pin on the southern side of Bonaventure Drive; thence with the southern side of Bonaventure Drive, N. 85-52 E. 150 feet to an iron pin; thence continuing with the southern side of Bonaventure Drive, S. 67-30 E. 95 feet to an iron pin at the intersection of said Bonaventure Drive and Botany Road; running thence with the curvature of said intersection 30.5 feet to an iron pin on the northern side of Botany Road; thence with the northern side of Botany Road, S. 37-00 W. 125 feet to an iron pin; thence continuing with the northern side of said Botany Road, S. 34-41 W. 130 feet to the point of beginning.

As a part of the consideration for this conveyance, the grantees expressly assume and agree to pay the balance due on that certain note and mortgage, in the original sum of \$40,000.00 executed by the grantor to the Fidelity Federal Savings and Loan Association and recorded in the R.
