ALL that certain piece, parcel or lot of land in the McAlister Plaza, in the City of Greenville, County of Greenville, State of South Carolina, on the northeasterly side of Edinburgh Court, being more particularly shown on plat entitled Portion of McAlister Plaza, prepared December 1961, and revised April, 1965, by Piedmont Engineering Service, said plat recorded in the office of the R.M.C. for Greenville County in Plat Book 199, Page 27, and having according to said plat the following metes and bounds, to-wit:
