KNOW ALL MEN BY THESE PRESENTS, that I, Helen L. Greenway, nee Owens,

in consideration of NINE THOUSAND and NO/100-----(\$9,000.00--- Dollars,

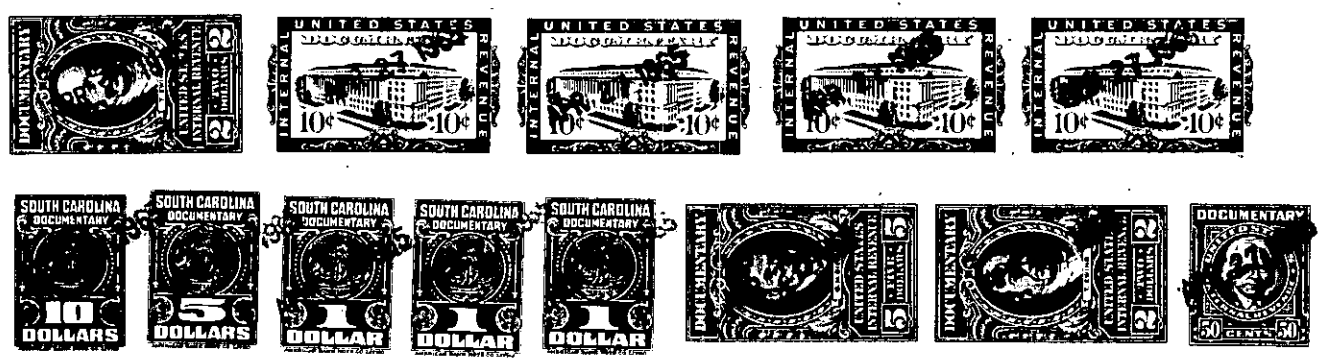
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Annie Belle Patton, her heirs and assigns:

All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, in Gantt Township, being shown as Lot No. 33 and a portion of Lots Nos. 34, 35, and 36 of property of Eliza T. Looper as shown by plat thereof prepared by R. E. Dalton and recorded in Plat Book H at Page 159 and also Plat Book AA at Page 107, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Keith Avenue at the joint front corner of Lots Nos. 33 and 32, said iron pin being 206.8 feet south of the southeastern intersection of Keith Avenue and Wilson Street and running thence with the line of Lot No. 32, N. 71-20 E. 151 feet to an iron pin at the joint rear corner of Lots Nos. 32 and 40; thence with Lot No. 40, N. 15-42 W. 56.4 feet to an iron pin at joint rear corners of Lots Nos. 40 and 33; thence continuing with Lot No. 40, N. 71-20 E. 4.1 feet to an iron pin at the rear corner of Lot No. 37; thence with Lot No. 37, N. 18-40 W. 25 feet to a point; thence across Lots Nos. 36, 34 and 35 in a line parallel with line of Lot No. 13, S. 71-20 W. 162.75 feet to an iron pin on the eastern side of Keith Avenue; thence with Keith Avenue S. 22-00 E. 81.5 feet to an iron pin, the beginning corner.
