release unto the said Leland W. Crim, Laurens I. James and James M. Burnette, their heirs and assigns forever:

"All that certain piece, parcel or lot of land being in or near the city of Greer, Greenville County, South Carolina and being identified as Lot No. Nine (9) on a plat entitled 'A Subdivision For McCall Manufacturing Company, Greer, S. C.' made by Pickell & Pickell, Engineers, Greenville, S. C. May 1949, and recorded in the R.M.C. Office for Greenville County in Plat Book S, at page 76, and according to said plat being more fully described as follows: BEGINNING at a point on Delano Street (Formerly Franklin Street), common corner of the lot herein conveyed and Lot 8, running thence along line of Lot 8 North 35-40 East 133.5 feet to point; thence North 58-22 West 79.2 feet to point; thence S 35-40 W 128 feet to point on Delano Street (Formerly Franklin Street); thence with said street South 54-20 East 79 feet to the BEGINNING corner, this being a portion of the property conveyed to the grantor by deed of E.
