BEGINNING at a point in the center of an old abandoned road (formerly known as Rutherford Road) and running thence S. 87 E. 140 feet more or less, crossing a small creek, to a stone; thence N. 56 E. 748 feet more or less to a stone; thence S. 23-12 E. 1033.2 feet, crossing a branch, to a stone; thence S. 66 W. 112.2 feet to a stone; thence N. 66 W. 264 feet to a stone; thence N. 50-30 W. 165 feet to a stone on the bank of said branch; thence in a southwesterly direction with the center of said branch as the line the following distances, all marked by a stone on the bank of said branch; 125.4 feet to a stone; thence 186. 12 feet to a stone; thence 165 feet to a stone at the juncture of said branch with a creek; thence with the center of said creek as the line S. 22-30 W. 283.8 feet to a point on the north side of Chick Springs Road; thence N. 87 W. 171.6 feet more or less, to a point in the center of said old abandoned Rutherford Road; thence with the center of said abandoned road as the line N. 3-30 W. 874 feet more or less, to point of beginning.
