BEGINNING at an iron pin on Old Rutherford Road, corner of Lot No. 2 and running thence along said Old Rutherford Road in a southerly direction 246.10 feet to an iron pin, corner of Lot No. 5; thence along joint lines of Lot No. 4 and 5 N 82½ W 286.9 feet to an iron pin on Cherry Street; thence along Cherry Street in a northerly direction 237.6 feet to an iron pin, corner of Lot No. 2; thence along joint line of Lots Nos. 2 & 3 S 83 E 303 feet to the beginning corner, being all of Lots Nos. 3 & 4 on a plat of land known as the J.
