BEGINNING at an iron pin on the western side of Mark Drive, corner of Lot 43, and running thence with the western side of said Drive, N. 14-00 E. 134.8 feet to iron pin at corner of Lot 34; thence with line of said lot N. 64-00 W. 156.1 feet passing an iron pin to the center of branch; thence with the center of branch as a line, the traverse of which is S. 15-49 W. 167.4 feet to the corner of Lot 43; thence with line of said lot, passing an iron pin S. 76-00 E. 158 feet to the beginning corner.
