Lee by their deed dated September 29, 1949 and recorded in the R.M.C. Office for Greenville County in deed Book 392, Page 544. This lot fronts on North Haven Drive, of this subdivision, and is the same lot conveyed to L. E. and Mrs. Ocey S. (2) That no building shall be erected on said lot costing less than the sum of \$2,000.00. (3) That no building shall be erected nearer the front line of said lot than 30 feet, nor nearer than 10 feet from either side line, or nearer than 5 feet from the rear line of said lot. (4) That the original Grantor reserves to itself and its successors the right to authorize the placing, maintaining and repairing of any and all public utilities in the streets without compensation to any lot owner. (5) That no surface closet nor cesspool shall ever be maintained on said land, but only septic tanks or other sanitary sewerage. (6) That no use of said lot shall be made which would constitute a nuisance to the adjoining lot owner. (7) All out-buildings are to be erected on rear of lot. together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appurtaning; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee's(s') heirs or successors and assign forever.
