across said parking area, said deed to be made in pursuance of Paragraph 3 (amending Paragraph 6 of the original Covenants) of the Amendment of Covenants Applicable to McAlister Plaza, said Amendment being recorded in the Office of the RMC for Greenville County in Deed Book 677, page 546.

Grantees agree that all utilities, including but not limited to water, electricity, sewerage and gas, shall, if possible, be brought to and maintained on said lot or parking area beneath the surface of the ground.

Grantor reserves for itself, its successors and assigns, an easement between the rear property line and the rear building line for the installation and maintenance of all utilities, including but-not limited to water, electricity, sewerage and gas. This property is subject to existing utility easements.

Grantor reserves for itself, its successors and assigns, an easement and alleyway (with right to improve same) 7½ feet in width, adjacent to and along the northeasterly property line for the purpose of egress and ingress for vehicular and pedestrian uses.

Grantor grants to grantees, their heirs and assigns, clients, and invitees, the right of egress and ingress in, over and through a strip of land of width sufficient for the passage of automobiles or other vehicles into the above described contiguous parking area from the entrances on the northeast side of Edgeworth Street.
