County, South Carolina, in Deed Book 664 at Page 65. Subsequently Jack Spalding, Jr. died testate and by the terms of his Will which is on file in the Probate Court for Greenville County, South Carolina, in Apartment 693, File 25, he devised the property owned by him at the time of his death to Robert E. Spalding. Subsequently Robert E. Spalding died testate and by the terms of his Will which is on file in the Probate Court for Greenville County, South Carolina, in Apartment 928, File 3, he constituted and appointed the Grantor herein as Executor and Trustee, giving said Executor and Trustee full power and authority to sell and convey any property owned by him at the time of his death.

There is embraced within the boundary of the tract of land last above described a tract of 3.81 acres on the East side of South Carolina Highway No. 14 and the said Robert Emmet Spalding was residing on this property at the time of his death. By Item 4 of his said Will he devised to the Grantor, Florence Haslett Spalding, any residence which he may own as a home at the time of his death. The above described tracts also are conveyed subject to the rights of way for roads shown on the survey made by J. C. Hill, Surveyor, dated July 22, 1966.

And the said granting corporation and the Grantor, Florence Haslett Spalding, do hereby bind ourselves and our heirs and successors to warrant and forever defend all and singular the said premises unto the Grantee hereinabove named, and its successors and assigns, against itself and its successors.
