ALL those lots of land, situate in Greenville County, South Carolina, on the Southeast side of Queensbury Drive, being shown as Lots 15 and 17 on plat of Section II of Canterbury Hills, made by Piedmont Engineering and Architects, March 19, 1964, recorded in the R.M.C. Office for Greenville County in Plat Book XX, Page 191, and having, according to said plat, the following metes and bounds, to-wit:
