

Know all Men by these presents, That I, NORMAN G. ANDERSON

in the State aforesaid,

in consideration of the sum of Ninety Thousand and No/100 (\$90,000.00) --- Dollars to me paid by JOHN E. MICKLER

in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said JOHN E. MICKLER, his heirs and assigns:

BEGINNING at a poplar on Rocky Creek, thence S. 6-00 E. 142 feet to a stone; thence N. 85-00 E. 69 feet to a stone; thence S. 25-23 E. 1240 feet to a stake; thence S. 27-45 E. 1933 feet to an iron pin; thence N. 72-00 E. 1010 feet to a stone; thence N. 12-00 W. 2464 feet to a stake on Rocky Creek; thence with the center of said creek as the line, S. 75-45 W. 278 feet to a point; thence S. 71-15 W. 309 feet to a point; thence S. 87-00 W. 584 feet to a point; thence N. 84-30 W. 220 feet to a point; thence N. 58-00 W. 456 feet to a point; thence continuing with the center said creek, N. 52-00 W. 276 feet to a poplar, the point of beginning.
