All that certain piece, parcel or lot of land situate, lying and being on the Northern side of Hathaway Circle, in Paris Mountain Township, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 97 of a subdivision known as Stratford Forest, and having according to a plat of said subdivision prepared by Piedmont Engineering Service, dated February 25, 1957, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book KK at page 89, the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Hathaway Circle at the joint front corner of Lots Nos. 96 and 97 and running thence with the line of Lot No.  $96\ N.\ 9-37\ E.\ 144.2$  feet to an iron pin; thence continuing with the line of Lot No.  $96\ N.\ 9-37\ E.\ 10$  feet to a point in the center of a creek; thence with the center line of said creek as the line in a Northwesterly direction to a point (having a traverse line as follows: beginning at an iron pin which is located S. 9-37 W. 10 feet from the last mentioned point; thence S. 89-25 W. 286.7 feet to an iron pin which is located S. 25-50 E. 10 feet from a point in the center line of said creek); thence from the point in said creek at the joint rear corner of Lots Nos. 97 and 98 and with the line of Lot No. 98 S. 25-50 E. 10 feet to an iron pin; thence continuing with the line of Lot No. 98 S. 25-50 E. 171.4 feet to an iron pin on the Northern side of Hathaway Circle; thence with the Northern side of Hathaway Circle N. 77-47 E. 90 feet to an iron pin; thence continuing with the Northern side of Hathaway Circle S. 87-42 E. 100 feet to the point of beginning.
