HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto
the said Thomas Olen Arms ALL the right, title and interest of the minor defendants, Johnnie Myron Forrester and Rebecca Ann Forrester, in and to the following described real estate:

All that tract of land in the County of Greenville, State of South Carolina, in Highland Township, known as Tract A-3 on plat of property of Henry A. Forrester, made by W. P. Morrow, dated August, 1930, containing 38.40 acres, more or less and having the following metes and bounds to wit: and bounds, to-wit:

BEGINNING at the southeastern corner of Tract A-2 in the center of BEGINNING at the southeastern corner of Tract A-2 in the center of Rutherford Road and running thence along the center of said Road.
