All that certain piece, parcel or lot of land with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the Northern side of Nottingham Road, being shown and designated as Lot No. 189 on a plat entitled "Sherwood Forest" dated August, 1951, prepared by Dalton & Neves, recorded in the R.M.C. Office for Green-ville County, South Carolina, in Plat Book GG at pages 2 and 3, a revision of such plat is recorded in Plat Book GG at pages 70 and 71, and having according to said plats, the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Nottingham Road at the joint front corner of Lots Nos. 188 and 189 and running thence with the line of Lot No. 188, N. 20-17 W. 203.5 feet to an iron pin at the joint rear corner of Lots Nos. 138 and 139; thence with the rear line of Lot No. 138, N. 62-46 E. 66.8 feet to an iron pin at the joint rear corner of Lots Nos. 189 and 190; thence with the line of Lot No. 190, S. 28-01 W. 214.8 feet to an iron pin on the Northern side of Nottingham Road; thence with the Northern side of Nottingham Road S.69-43 W. 95.5 feet to the point of beginning. This conveyance is made subject to a 30-foot building line and restrictions, easements and rights of way, if any, which may affect the above-described property.
