

all that piece, parcel or lot of land in Butler

Township, Greenville

County, State of South Carolina , on the south side of United States Highway No. 29 and being known and designated as Lot No. 2 as shown on plat made by W. J. Riddle February 5, 1937, and having the following metes and bounds, to wit: according to said plat:

BEGINNING at a pin on the said Highway corner of Lot No. 1, the same being 706 feet from the intersection of the White Oak Road and said Highway and running thence with the line of Lot No. 1, S. 37-34 E. 698 feet to an iron pin on line of Lot No. 11; thence with line of Lot No. 11, S. 65-42 W. 421.3 feet to an iron pin corner of Lot No. 3; thence with the line of Lot No. 3, N. 37-34 W. 606 feet to an iron pin on said Highway; thence with said Highway, N. 52-26 E. 410 feet to the beginning corner, and containing 6.14 acres, more or less, being the same land conveyed to the Grantor by the deed of Anne E. Bradley recorded in Deed Book 192, at Page 121.

Also, all that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, lying and being on the south side of the new U. S. Highway No. 29, known and designated as Lot No. 3 of the Bradley Estate shown on plat of Dalton & Neves, August 1939 and having the following metes and bounds, to wit:

BEGINNING at an iron pin on said new U. S. Highway No. 29, joint corner of Lots 2 and 3 and running thence with said lots S. 37-34 E. 606 feet to an iron pin in line of Lot No. 11; thence S. 65-42 W. 154.2 feet to an iron pin corner of Lot No. 4; thence with line of Lot No. 4, N. 37-34 W. 568 feet to an iron pin on said Highway; thence with said Highway No. 52-26 E. 150 feet to the beginning corner, being the same lot of land conveyed to the Grantor by the deed of Anne E. Bradley recorded in Deed Book 222, at Page 105.

Also, all that piece, parcel or lot of land located in Butler Township, Greenville County, State of South Carolina, on the southeast side of U. S. Highway No. 29 and being known and designated as Lot No. 1-A of Bradley Estates, as shown on a plat of W. J.
