
the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto

BEGINNING at an iron pin on the southerly side of Vicksburg Drive at the joint front corner of Lots 4 and 5 and running thence with the common line of said lots, S. 29-15 W., 150 feet to an iron pin; thence S. 64-10 E., 103.3 feet to an iron pin on the Easterly side of Dinwiddle Drive; thence with said Drive, N. 29-15 E., 125 feet to an iron pin; thence around the curve at the intersection of Dinwiddle Drive and Vicksburg Drive (the chord of which is N. 16-56 W.) 34.2 feet to an iron pin on the Southerly side of Vicksburg Drive; thence with said Drive, N. 64-10 W., 78 feet to the point of beginning.
