the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto **GERALD L. KEENER, his heirs and assigns, forever :**

ALL that certain piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville County, State of South Carolina, being known as the rear portion of Lot No. 10 on plat of property of J. R. West, surveyed by Thomas T. Linder, August 16, 1937, and recorded in the R.M. C. Office for Greenville County in Plat Book D, at Page 268, and having the following metes and bounds, to wit:

BEGINNING at a point on the joint line between Lots Nos. 10 and 11 on the west side of West Avenue, which point is 110.5 feet from the joint front corner of Lots Nos. 10 and 11 on the west side of West Avenue and running thence with the joint line of Lots Nos. 10 and 11 S. 73-45 W. 60 feet to a stake; joint rear corner of Lots Nos. 10 and 11; thence S. 14-45 E. 66 feet to a stake, joint rear corner of Lots Nos. 9 and 10; thence with the common line of Lots Nos. 9 and 10 N. 73-45 E. 60 feet to a point on the joint line between Lots Nos. 9 and 10 112.5 feet from the joint front corner of Lots Nos. 9 and 10 on the west side of West Avenue; thence along a line parallel with the rear line of Lot No. 10 N. 14-45 W. 66 feet to the point of beginning.

Grantee to pay 1967 taxes on property hereby conveyed.

This being a part of the properties conveyed to grantor by deed dated October 14, 1952, and recorded in the R.M.C. Office for said County and State in Deed Book 473 at Page 170.
