to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Myrtle Louise Whitman and LeRoy Whitman and their heirs and assigns forever:

All that certain parcel or lot of land situated on the north side of Crain Drive, near Fairview Baptist Church and about one-half mile from the limits of the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, and being Lot No. 45 of the property of John B. and Mencie N. Crain Estates according to survey and plat by H. S. Brockman, Surveyor, dated May 12, 1948, and recorded in Plat Book Y, page 79, R.M.C. Office for Greenville County and having the following courses and distances, to-wit:
