Janet P. Copeland, an undivided one-third interest, Danny L. Copeland, same as Danny L. Hill, an undivided one-third interest, and James J. Copeland, same as James J. Hill, Jr., an undivided one-third interest, their heirs and assigns

All that lot of land situate on the southeast side of Henderson Road in the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 19 on plat of Section E-1 of Gower Estates, made by Campbell & Clarkson, Surveyors, December 1964, recorded in the RMC Office for Greenville County, S.C. in Plat Book BBB at page 70 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeast side of Henderson Road at the joint front corner of Lots 18 and 19, and runs thence along the line of Lot 18, S. 38-00 E. 308.4 feet to an iron pin; thence N. 52-34 E. 150 feet to an iron pin; thence along the line of Lot 20, N. 33-17 W. 299.5 feet to an iron pin on the southeast side of Henderson Road; thence along Henderson Road, S. 55-45 W. 175 feet to the beginning corner.

This conveyance is subject to all restrictions, set back lines, roadways, easements and rights of way, if any affecting the above described property. For restrictions applicable to Section E-1 of Gower Estates, see Deed Book 769 at page 259. This property is also subject to the drainage easement across the front of the lot, as shown on recorded plat.

This being the same property conveyed to the grantor herein by deed recorded in Deed Book 828 at page 465.

As a part of the consideration for this conveyance, the grantees assume and agree to pay the balance on a mortgage to Fidelity Federal Savings & Loan Association in the amount of \$30,000.00 recorded in Mortgage Book 1069 at page 350 in the RMC Office for Greenville County. Authority to assume this mortgage was given pursuant to Judgment Roll J-10,275,Office of Clerk of Court.
