M. A. Jernigan and Ida Jernigan, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as Lot No. 94 as shown on a Plat of Golden Grove Estates by Dalton & Neves, Engineers, dated September, 1965 recorded in the R. M. C. Office for Greenville County in Plat Book JJJ at Page 97, and having according to said Plat, the following description, to-wit:

Lot 94 Criss Drive:

BEGINNING on Criss Drive at an iron at joint front corners of Lots 93 and 94 and running thence 75 feet with the line of Criss Drive to an iron pin at joint front corners of lots 94 and 95; running thence 200 feet with the side line of lot 95 to an iron pin at joint rear corners of lots 94, 95, 86 and 87; running thence 75 feet with the rear line of lot 87 to an iron pin at joint rear corners of lots 87, 88, 93 and 94; running thence 200 feet with the side line of lot 93 to the iron pin at joint front corners of lots 93 and 94 on Criss Drive the point of hegipping. NO residence to cost less than \$10,000.00 shall be erected on any lot; no residence shall be erected on lots nearer than 35 feet to the front line; the building line setback is 100 feet for lots 20 and 21; no residence shall be built on any lot unless said lot has 70 feet or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks; all lots to be used for residential purposes, only, except lots 43, no residence shall to be used for residential purposes, only, except lots 43, 44, and 75.

THIS conveyance is subject to all easements and rights of way of record.
