Highway 14 and on the northwestern side of Phillips Road and the northern side of new S.C. Highway 14, containing 17.10 acres, more or less, and shown on plat of property of the grantee by Piedmont Engineers & Architects recorded in Plat Book XXX at page /83, in the RMC Office for Greenville County and having the following metes and bounds:
