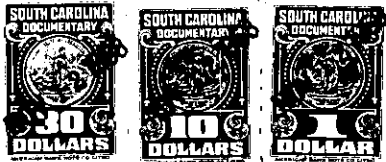
KNOW ALL MEN BY THESE PRESENTS, that **GENERAL FOODS CORPORATION**
