All those certain pieces, parcels or lots of land, lying and being on the easterly side of Woodberry Way, near the City of Greenville, S. C., being shown as Lots Nos. 23 and 24 on the plat of Hollyvale as recorded in the RMC Office for Greenville County, S. C. in Plat Book Y, at page 131 and having according to said plat, the following metes and bounds, to-wit:
