


in consideration of Exchange of property valued at Nine Thousand and No/100 (\$9,000.00) plus assumption of mortgage loan (see below) the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto ... M. Eugene Baughcome and Irene G. Baughcome, their heirs and assigns forever:

All that piece, parcel or lot of land lying, being and situate on the South side of East Georgia Road, in the Town of Simpsonville, County and State aforesaid, and being known and designated as Lot No. Six (6) of the Lawrence L. Knighton, et al. property, as shown on plat prepared by H. S. Brockman, Reg. Surveyor, dated Aug. 28, 1963 and which plat will be recorded forthwith in the R.M.C. Office for said County, and having the following courses and distances, to-wit:

BEGINNING at an iron pin on the South side of said road at the joint front corner of Lots Nos. 5 and 6 as shown on said plat, and running thence with the joint property line of said two lots S. 8-15 E. 191 feet to an Iron Pin located at the joint rear corner of Lots Nos. 5 and 7 as shown on said plat, thence with the joint property line of said lots Nos. 6 and 7 S. 8-47 E. 68.7 feet to an iron pin located at a joint corner of lots Nos. 6, 7 and 8 as shown on said plat, thence with the joint property line of said lots Nos. 6 and 8 N. 81-29 E. 148.2 feet to an Iron Pin, thence N. 41-14 W. 81.3 feet to an Iron Pin, thence N. 8-15 W. 191 feet to an Iron Pin onthe South side of the East Georgia Road, thence with the South sideof said road S. 81-33 W. 104.5 feet to the beginning point. For a more particular description see the aforesaid plat.

This is the same property conveyed to Grantors by Deed dated July 21, 1961, and recorded in Deed Book 681 at page 422, and any correction in metes and bounds were cleared up by the additional Quit Claim Deed, dated August 29,1963, and recorded in Deed Book 731 at page 311.

This conveyance is made subject to any Restrictive Covenants, building set-back lines, rights of way and easements which may affect the above described property.

As a part of the consideration herein, the Grantee herein assumes and agrees to pay the balance due on that certain note and mortgage given by Lawrence L. Knighton and Jean T. Knighton to Woodruff Federal Savings & Loan Association in the original amount of \$14,500.00. The balance on said mortgage for assumption is \$11,800.00
