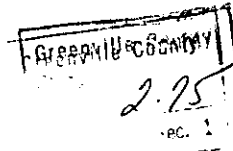
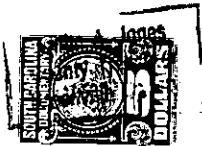

All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southerly side of Hunting Hollow Road, near the City of Greenville, S. C., being designated as Lot No. 111, of Section I, Foxcroft as recorded in the RMC Office for Greenville County, S. C., in Plat Book 4F, pages 2, 3 and 4 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Hunting Hollow Road, said pin being the joint front corner of Lots 111 and 112 and running thence with the common line of said lots S 10-09 E 165 feet to an iron pin, the joint rear corner of said lots; thence turning and running N 79-51 E 130 feet to an iron pin, the joint rear corner of Lots 110 and 111; thence turning and running with the joint line of Lots 110 and 111 N 10-09 W 165 feet to an iron pin on the southerly side of Hunting Hollow Road; thence turning and running along the southerly side of Hunting Hollow Road S 79-51 W 130 feet to the point of beginning.
