10. Lessee shall, upon termination of the terms of this lease or of Lessee's right to possession, return to Lessor the premises and allequipment and fixtures comprising a part thereof, in as good condition as when Lessee took possession, excepting only ordinary wear and tear and damage by fire or other casualty for which Lessee is not legally responsible.

To the full and faithful performance of the terms and conditions of this lease, the parties hereto bind themselves, their executors, adminstrators, successors and assigns.
