The right of way is to and does convey to the grantee, its successors and assigns the following: The right and privilege of entering the aforesaid strip of land, and to construct, maintain and operate within the limits of same, pipe lines, manholes, and any other adjuncts deemed by the grantee to be necessary for the purpose of conveying sanitary sewage and industrial wastes, and to make such relocations, changes, renewals, substitutions, replacements and additions of or to the same from time to time as said grantee may deem desirable; the right at all times to cut away and keep clear of said pipe lines any and all vegetation that might, in the opinion of the grantee, endanger or injure the pipe lines or their appurtenances, or interfere with their proper operation or maintenance; the right of ingress to and egress from said strip of land across the land referred to above for the rights herein granted shall not be construed as a waiver or abandonment of the grantee to exercise any of the rights herein granted shall not be construed as a waiver or abandonment of the right thereafter at any time so close thereto as to impose any load thereon.  3. It is Agreed: That the grantor(s) may plant crops, maintain fences and use this strip of land, provided: that crops shall not be planted over any sewer pipes where the tops of the pipes are less than eighteen (18) inches under the surface of the ground; that the use of said strip of land by the grantor shall not, in the opinion of the grantee, interfere or conflict with the use of said strip of land by the granter for the purposes herein mentioned, or render inaccessible the sewer pipe line or their appurtenances.  4. It is Further Agreed: That in the event a building or other structure should be erected contiguous to any damage that might occur to such structure, building or contents thereof due to the operation or maintenance, of said pipe lines or their appurtenances, or any accident or mishap
	5. All other or special terms and conditions of this right of way are as follows:
	During construction the right-of-way herein granted shall be 50 feet wide, extending 25 feet on each side of the center line.
