

BEGINNING at the northwest intersection of Marion Road and Parker Road and running thence along Parker Road, N. 51-44 W. 185 feet to a point; thence turning and running N. 40-23 E. 184.5 feet to a point; thence turning and running S. 51-52 E. 185 feet to a point on Marion Road; thence turning and running along Marion Road, S. 40-23 W. 184.6 feet to the point of beginning.

This conveyance is made subject to any restrictions, rights-of-way, or easements that may appear of record on the recorded plat(s) or on the premises.
