- 2. Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; or any leases, rents or funds held under escrow agreement relating to said premises; and
- 3. The property referred to by this agreement is described as follows: &11 that lot of land on the southern side of Crestmore Dr. in the County of Greenville, S. C., being shown as Lot 17 and a 10-foot strip adjoining lot 17 as shown Plat of Property of Carroll Wayne Henson and Sandrs B. Henson prepared by R. B. Bruce, R. L. S., recorded in the RMC Office for said County in Plat Book XXX at page 189 and more fully described as follows: Beginning at an iron pin on Crestmore Drive at the joint front corner of Lots 17 & 18 and running thence with line of said lots, S 15-43 B 148.9 feet to an iron pin; thence N 72-35 E 60 feet to an iron pin; thence N 9-20 W 49 feet to an iron pin; thence N 72-35 E 10 feet to an iron pin; thence N 9-20 W 100 feet to an iron pin on Crestmore Dr., thencewith said Drive, S 73-08 W 86.8 feet to an iron pin at point of beginning .

That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith.
- 5. That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.
- 6. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
