and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by FRANK P. McGOWAN, JR., as Master in and for the County aforesaid, to Ernest Goldsmith, Bernest Goldsmith, Sally G.
Kilgore, Donnie G. Clowney and Edward Durham,

NOW, Therefore, Know all Men by these Presents, that I, FRANK P. McGOWAN, JR., as Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, and consideration of \$40.00 having been previously paid prior to this action, HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said Ernest Goldsmith, Bernest Goldsmith, Sally G. Kilgore, Donnie G. Clowney and Edward Durham:

ALL of that certain piece, parcel or lot of land, containing 1.00 acre, situate, lying and being near Simpsonville, in the County of Greenville, State of South Carolina, as shown on a plat entitled "Property of Henry Goldsmith Est." dated June 25, 1971, prepared by C. O. Riddle, Reg. L.S., recorded in the R. M. C. Office for Greenville County in Plat Book 4-K, at page 109, and having according to said plat the following metes and bounds to-wit:

BEGINNING at an iron pin (said iron pin being in an easterly direction from the northeastern corner of property now or formerly of James Albert Pennington measured from an i.p.o. N. 11-06 W. 100 feet to an i.p., thence N. 89-47 E. 352.2 feet to a point and S. 13-45 W. 22.7 feet thereto) and running thence N. 13-45 E. 160 feet to an i.p.; thence S. 76-15 E. 272.25 feet to an i.p.; thence S. 13-45 W. 160 feet to an i.p.; and, N. 76-15 W. 272.25 feet to the point of beginning.

In addition to the above described property an easement for ingress and egress thereto is hereby conveyed along, through and over that certain roadway as shown on said subject plat extending approximately 352.2 feet long.
