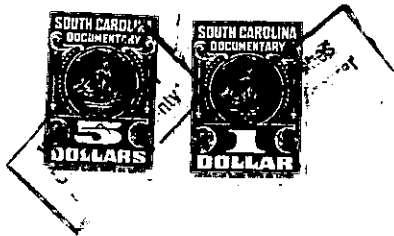
KNOW ALL MEN BY THESE PRESENTS, that Phillip S. Norris and Martha M. Norris -----
