ALL that piece, parcell or tract of land near the intersection of U. S. Highway I-85, and U. S. Highway No. 276 (Laurens Road), near the City of Greenville, in Greenville County, South Carolina, being the Southernmost rear portion of 8 acres, designated as the Property of Greenville Leasing Co., Inc., on a Plat made by Dalton & Neves, Engineers, dated November, 1963, and recorded in the RMC Office for Greenville County, S. C., in Plat Book GGG, pages 128 and 129, and having according to a recent survey of the same made by Carolina Engineering & Surveying Co. dated May 21, 1971, the following metes and bounds, to wit:
