OLLIE FARMSWORTH REAL PROPERTY AGREEMENT

In consideration of such loans and indebtedness as shall be made by or become due to THE SOUTH CAROLINA NATIONAL BANK OF CHARLESTON (hereinafter referred to as "Bank") to or from the undersigned, jointly or severally, and until all of such loans and indebtedness have been paid in full, or until twenty-one years following the death of the last survivor of the undersigned, whichever first occurs, the undersigned, jointly and severally, promise and agree

- 1. To pay, prior to becoming delinquent, all taxes, assessments, dues and charges of every kind imposed or levied upon the real property described below; and
- Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than
 those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; or any leases, rents or funds held under escrow agreement relating to said premises; and
 - 3. The property referred to by this agreement is described as follows:

All that certain piece, parcel or lot of land, with all improvements theron, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Highland Township, consisting of 33.1 acres, more or less, and being more particularly described by a plat prepared by J. G. Bruce, August 27, 1965, and recorded in the RMC Office of Greenville County in Plat Book GGGG at page 297 as follows: Beginning at an iron pin in the cuater of a county road and running thence along property of the grantor, S 17-h3 W 1927.5 feet to an iron pin: thence S 66-37 W 603 Feet to an old stone; thence along property now or formerly owned by Barton, N 25-37 W1963 in feet to the center of the said road, N 64 E 278.5 feet; (Continued on back)

That if default be made in the performance of any of the terms hereof, or if default be made to any puyment of principal or interest, on any notes hereof or hereafter signed by the undersigned, the undersigned agrees and does hereby assign the rents and profits arising or to arise from said premises to the Bank and agrees that any judge of jurisdiction may, at chambers or otherwise, appoint a receiver of the described premises, with full authority to take possession thereof and collect the rents and profits and hold the same subject to the further order of said court.

That if default be made in the performance of any of the terms hereof, or if any of said rental or other same be not paid to ak when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedus then remaining unpaid to Bank to be due and payable forthwith.
- 5. That Bonk may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.
- 6. Upon payment of all indebtedness of the undersigned to Bunk this agreement shall be and become void and of no effect, and until then it shall apply to und bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Pank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is bereby authorized to rely thereon.
