## REAL PROPERTY AGREEMENT

In consideration of such loans and indebtedness as shall be made by or become due to THE CITIZENS AND SOUTHERN NATIONAL BANK OF SOUTH CAROLINA (hereinafter referred to as "Bank") to or from the undersigned, jointly or severally, and until all of such loans and indebtedness have been paid in full, or until twenty-one years following the death of the last survivor of the undersigned, whichever first occurs, the undersigned, jointly and severally, promise and agree

Without the prior written consent of Sank, to refrain from creating or permitting any lien or other endumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein, and

All that certain piece, parcel or lot of land situate, lying and being in Highland Township, said County and State, on the north side of Few's Chapel Road, about one-fourth of a mile east of Few's Chapel Church, being shown and designated as Lot No. 1 on a plat of property prepared by J. Q. Bruce, Surveyor, April 19, 1957, for W. H. Campbell, and recorded in Plat Book NN, page 63, R.M.C. Office for Greenville County, and having the following courses and distances, towit:

BEGINNING at an iron pin, joint near corner of Lets Nos. 1 and 2, and running thence with the line of W. H. Campbell, N. 18-42 W. 184.8 feet to an iron pin, joint corner of Hazel C. Edwards and W. H. 3. That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.

Upon payment of all indebtedness of the underliqued to Sank this agreement shall be and become void and of no effect, and until then it shall apply to and hind the discoveraged, their heirs, legates, devises, administrators, executors, successors and assigns, and inuse to the benefit of Bank are its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtribess to recain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may unclin baseby authorized to rely thereon.
