HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said Myra Juanita Bowers Howard:

Land located in Chick Springs Township, Greenville County, South Carolina, located on the east side of the Suber Road and on Princess Creek about 3 miles south of City of Greer, containing 7.40 acres more or less and being a portion of the W.
