the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Theodore C. Breimann, Avinell M. Breimann and Ida R. Breimann, their heirs and assigns forever:

ALL that piece, parcel or lot of land situate, lying and being on the Western side of Greentree Road near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #176 as shown on a plat of Pineforest Subdivision prepared by Dalton and Neves, dated August, 1959, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "QQ" at pages 106 and 107, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Western side of Greentree Road at the joint front corner of lots 175 and 176, and running thence with the line of lot #175 S. 78-26 W. 176.2 feet to an iron pin in the rear line of Lot #6; thence with the rear lines of lots 6 and 7 S. 4-38 E. 80 feet to an iron pin at the joint rear corner of lots 176 and 177; thence with the line of lot #177 N. 65-31 E. 178.4 feet to an iron pin on the Western side of Greentree Road; thence with the Western side of Greentree Road S. 14-58 E. 40 feet to an iron pin; thence continuing with the Western side of Greentree Road S. 4-38 E. 80 feet to the point of beginning.
