REAL PROPERTY AGREEMENT

In consideration of spontages and indebtedness as shall be made by or become due to THE SOUTH CAROLINA NATIONAL BANK OF CHARLESTON described by the second of spontages and indebtedness have been paid in full, or until twenty-one years following the death of the last survivor of the undersigned, whichever first occurs, the undersigned, jointly and severally, promise and agree

Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; or any leases, rents or funds held under excrew agreement relating to said premises; and
 - 3. The property referred to by this agreement is described as follows:

All that lot of land with the buildings and improvements thereon, situate on the northeast side of Meyers Drive, in the City of Green-ville, in Greenville County, South Carolina, being shown as Lot No. 22 and the adjoining one-half of Lot 21 on Plat No. 2 of Sunset Hills, made by R. E. Dalton, Engineer, December 1945, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "P", at Page 19, said lot fronting 112.5 feet along the northeast side of Meyers Drive and running back to a depth of 175.7 feet on the southeast side, to a depth of 175.7 feet on the northwest side and being 112.5 feet across

That if definit being in the performance of any of the terms hereof, or if default be made in any payment of principal or interest, on any notes hereof or hereafter signed by the undersigned, the undersigned agrees and does hereby assign the rents and profits arising or to arise from said premises to the Bank and agrees that any judge of jurisdiction may, at chambers or otherwise, appoint a receiver of the described premises, with full authority to take possession thereof and collect the rents and profits and hold the same subject to the further order of said court.

That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith.

The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
