all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the eastern side of "D" Street, near the City of Greenville, being shown as Lot No. 43 on Plat of Section 6 of Judson Mill Village, made by Dalton & Neves, Engineers, in November, 1941, and recorded in Plat Book "K", Pages 106 and 107, and described as follows:

BEGINNING at an iron pin on the east side of "D" Street, joint front corners of Lots #42 and #43, and running thence with the line of Lot #42 N. 88-23 E. 78 feet to an iron pin, joint rear corner of Lots #30 and #31; thence with the rear line of Lot #30 S. 1-37 E. 70 feet to an iron pin, joint corner of Lots #29, #30, #43 and #44; thence with the line of Lot #44 S. 88-23 W. 78 feet to an iron pin on the east side of "D" Street; thence with "D" Street N. 1-37 W. 70 feet to the beginning corner; said premises being the same conveyed to the grantor by CLARENCE E.
