All that lot of land in the State of South Carolina, County of Greenville, near the Town of Simpsonville, being located at the intersection of Neely Ferry Road and Stenhouse Road, fronting on the northerly edge of Stenhouse Road and having the following metes and bounds according to a plat prepared by C. C. Jones, Engineer:

BEGINNING at a point in the center of Neely Ferry Road at the point where the center line of Stenhouse Road intersects with said Neely Ferry Road and running thence with the center of Stenhouse Road, N. 76-23 W., 200 feet to a point in Stenhouse Road; thence continuing with Stenhouse Road, N. 73-21 E., 135.4 feet to a point in said road; thence N. 10-29 E., 24 feet to an iron pin on the northern side of Stenhouse Road; thence N. 19-47 E., 237 feet to an iron pin; thence S. 48-32 E., 330 feet to a point in the approximate center of Neely Ferry Road; thence along said Road, S. 8-30 W., 39.4 feet to a point; thence continuing with Neely Ferry Road, S. 2-30 W., 75 feet to the point of beginning.
