ALL that piece, parcel or tract of land, together with all buildings and improvements thereon, situate, lying and being on the Eastern side of Piney Mountain Road, lying between the rights of way of Southern Railway and P. and N. C., on February 7, 1966, in Mortgage Book 1021, page 655, which has a present balance due in the sum of \$12,401.29
