ALL those pieces, parcels or lots of land situate, lying and being in the County of Greenville, State of South Carolina, and being known and designated as Lots 12, 13, 14 and 15 of Section B and Lots 2, 3, 4, 5, 6, 7, 9, 10, 11, 12, 13 and 14 of Section C and Lots 10, 12, 13 and 14, of Section D of Roosevelt Heights Subdivision, according to a plat prepared of said property by J. Mac Richardson, registered L.S., March, 1950, and recorded in the R.M.C.
