his interest in whole or in part, the assignee of such Partner shall have a vote in direction proportion to the interest in the capital of the Partnership held by such assignee.

- (b) <u>SIGNATURES</u>: Any deed, bill of sale, mortgage, security instrument, lease, contract of sale, document or other commitment purporting to convey or encumber the interest of the Partnership in all or any portion of any real or personal property shall be signed by a majority in interest of the Partners. In the event a Partner shall sell or otherwise dispose of his interest in whole or in part, the assignee of such Partner shall be entitled to execute any of the documents enumerated herein according to the percentage of interest in the capital of the Partnership held by such assignee.
- (4) SUCCESSORS IN INTEREST: Except as otherwise provided herein, all provisions of this Agreement shall be binding upon, inure to the benefit of, and be enforceable by and against the respective heirs, executors, administrators, personal representatives, successors and assigns of any of the parties to this Agreement.
