KNOW ALL MEN BY THESE PRESENTS, that J. O. Lindley, of Greenville County,

in consideration of Ten Dollars (\$10.00) and Love and Affection Dollars,  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto J. O. Lindley, his heirs and assigns, all that certain piece, parcel or Lot of land situate and being in Grove Township, State and County aforesaid, containing three and thirteen hundredths (3.13) acres, more or less. Adjoining lands of myself, lands of Duff Jamison (Now or formerly), and possibly others. and being designated as Lot No. 5.

Having the following mates and bounds, to wit:

beginning at a point on Duff Jamison line at joint corner of Lot C, and running thence with Jamison line N. 77:35 W. 595 feet to joint corner of Lot D; thence N. 24:44 E. 237.4 feet to a point in black top road; thence with said road N. 70:44 E. 18 feet to an angle in said road; thence S. 85:55 E. 100 feet to an angle; thence S. 65:35 E. 200 feet to an angle; thence N. 45:34 E. 240 feet to joint corner of Lot C; thence with line of Lot C S. 12:25 W. 200 feet to beginning corner.

ALSO, all that certain piece, parcel or Lot of land situate and being in Grove Township, State and County aforesaid containing four and thirteen hundredths (4.13) acres, more or less.

Adjoining lands of myself, Piedmont and Northern Railway, Duff Jamison (Now or formerly) and possibly others.

Having the following mates and bounds, to wit:

beginning at a point in black top road, joint corner of Lot D, thence S. 14:14 E. 30 feet to point at Jamison line; thence with Jamison line N. 77:35 W. 705 feet to iron pin at Piedmont and Northern Railway; thence along said Railway N. 43:40 E. 290 feet to joint corner of Lot No. 7; thence S. 77:35 E. 420 feet to a point in black top road; thence with said road S. 44:16 E. 40 feet to a point in said road; thence S. 14:16 E. 165.5 feet to joint corner of Lot No. 4; thence S. 19:16 E. 210 feet to a point in black top road at corner of Lot No. D; thence with said road S. 70:44 W. 100 feet to a point in said road; the beginning corner.
