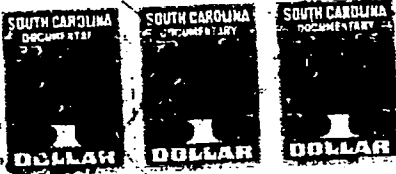
KNOW ALL MEN BY THESE PRESENTS, that I, MARY C. TAYLOR,
