All that piece, parcel or lot of land situate, lying and being on the northern side of Page Drive, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot 7 of Lockwood Heights Section 1, and having according to a plat prepared by Jones & Sutherland, Engineers, dated March 14, 1958, entitled "Property of Mrs. Lula B. Thruston", recorded in the RNC Office for Greenville County, South Carolina, in Plat book PP at page 101, the following metes and bounds:

BEGINNING at an iron pin on the northern side of Page Drive at the joint front corner of Lots 6 and 7 and running thence with the line of Lot 6, N. 21-00 W. 100 feet to an iron pin; thence S. 09-00 W. 30 feet to an iron pin at the joint rear corner of Lots 7 and 8; thence with the line of Lot 8, S. 21-00 E. 100 feet to an iron pin on the northern side of Page Drive; thence with the northern side of Page Drive, N. 09-00 E. 30 feet to the point of beginning.
