Allen's corner; thence N. 72 E. 150.0175.0 poles to a rock in the old Bunccombe Rd. thence S. 10- E 20 poles to a stone; thence N. 88 E. 45 poles to a rock; thence N. 10- W. 67 poles to a stake. thence N. 81- W. 42 poles to Bunccombe Rd. thence S. with the Bunccombe Rd. to the beginning corner. Also However, a tract of land containing 26 acres, more or less, conveyed by W. G. Boyne to W.H. Boyne by deed recorded in the L.M.C. office for Greenville County, in deed book 535, page 191, and having the following metes and bounds, to-wit: Beginning at a stone on the Bunccombe Rd. and running thence S. 72-00 W. 1138 feet to a stone; thence S. 57-30 W. 1320 feet to a stake; thence S. 2-00 W. 256 feet to the W.B. Allen's corner; thence N. 72-00 E 2475 to a stone in the old Bunccombe Rd. thence with the old Bunccombe Rd. as the line S. 10-00 E. 330 feet to an iron pin in the old road; thence N. 88-00 E. 183 feet to an iron pin on the south shoulder of the road; thence with the road as the line N. 31-41 W. 175 feet to a bend in the road; thence N. 22-10 W. 100 feet to a bend in the road; thence N. 15-45 W. 634 feet to a stone, the beginning corner.
