Without the prior written consent of Bank, to refrain from creating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; or any leases, rents or funds held under escrow agreement relating to said premises; and
- 3. The property referred to by this agreement is described as follows: Peginning at a point in the center of ... Duncan Rd. 854.5 feet Southwesterly from the intersection of Duncan Rd. and Hellum Crossing Rd. and running thence N. 75-24 E. 197.8 ft. to an old iron pin; thence, along a line of land of Wade W. Hix S. 22-17 E. 1310.2 ft. to an old iron pin; thence, S. 66-33 W. 101.2 ft. to a stone; thence, S. 57-03 W. 570.1 ft. to an old iron pin; thence, N. 88-19 W. 12h.8 ft. to a point; thence N. 48-40 W. 214.0 ft. to a point in the center of creek; thence, down the center of the creek as the line by the travers line S. 78-38 E. 151.9 ft. to a point in the center of a bridge across said creek; thence, along the center of Duncan Rd.  - 5. That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.
 - 6. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
