KNOW ALL MEN BY THESE PRESENTS, JAMES T. LYNN, Secretary
of Housing and Urban Development, of Washington, D. C., acting by and
through the Federal Housing Commissioner, (hereinafter referred to as
"Grantor"). For and in consideration of the sum of ----Twenty Two Thousand
Five Hundred and no/100----- DOLLARS (\$ 22,500.00), has granted,
conveyed, sold and released, and by these presents does grant, bargain,
and release unto JERRY W. BRYANT

hereinafter referred to as "Grantee(s)", and to the heirs and as-
signs of said Grantee(s), the following described real estate situate
in the County of GREENVILLE, State of South Carolina, to wit:

to, that lot of land in the County of Greenville, State of South
Carolina, at the northwest corner of Welcome Road and Alden Court,
being unnumbered on plat recorded in Plat Book #3 at page 14 of the
Office for Greenville County, S. C., and having according to
a survey made by Jones Engineering Service, August 10, 1969
the following lines and bounds, courses and distances, to-wit:

beginning at an iron pin on the southwest side of Welcome Road,
corner of lot No. 1; thence with the line of said lot S. 31-55 W.
108.6 feet to an iron pin corner of lot No. 1; thence with the line
of said lot S. 31-55 E. 111.0 feet to an iron pin on the Northwest
line of Alden Court; thence with the Northwest side of said Street
N. 31-55 E. 105.6 feet to an iron pin; thence with the curve of said
lot as it intersects with Welcome Road, the chord of which is
N. 31-51 W. 101.9 feet to an iron pin on the southwest side of Welcome
Road; thence with the southwest side of Welcome Road N. 31-50 W. 53
